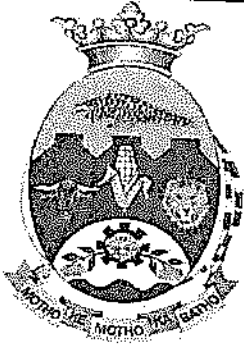

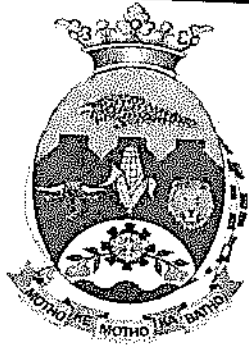



Council Resolved:

- That Councillor Ledwaba be granted indemnity from personal liability arising from the criminal case she opened against Ms Ledwaba for destruction of Municipal Property and the civil case under case number 536/21. Any amount which a court of law may order against her would be paid by the Municipality in view of the indemnity.
- That the Municipality should provide Councillor Ledwaba with legal representation which will include the appointment of Attorneys and Advocates from the Municipality's panel of attorneys for the proceedings instituted against her under case number 536/21.
- That the Acting Municipal Manager in consultation with the Speaker was directed to ensure that Councillor Ledwaba was provided with legal assistance from the Municipality's panel of attorneys with immediate effect.
- The Speaker should formally advise Councillor Ledwaba of the indemnity and legal assistance granted by Council.
- In the event this Council resolution was challenged such proceedings should be defended. Council further authorises the Speaker and the Acting Municipal Manager to take whatever action they consider necessary to protect the interest of Council regarding the implementation of this resolution.
- That going forth all welfare issues of councillors should be handled from Office of the Speaker
