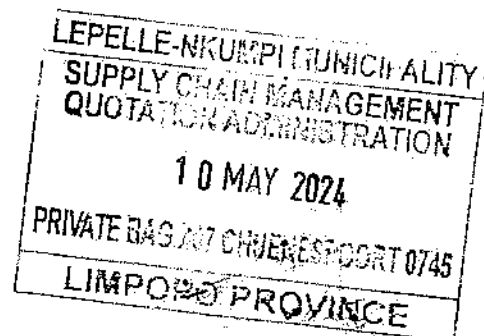
No late quotations will be accepted.
