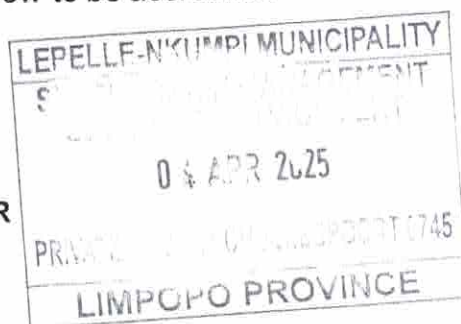
**No late quotations will be accepted.**
