**Bid documents will be available from the municipal website ([www.lepelle-nkumpi.gov.za/E-tenders](http://www.lepelle-nkumpi.gov.za/E-tenders) portal, downloadable for free and official closing time for submission of bids is 11h00. Bid document fully completed, priced, initialized on all pages, sealed in an envelope marked with the bid number and description should be deposited in the bid box at Municipal Offices (Civic Centre) Unit F, Lebowaqomo, on or before closing date and time. The municipality will not take responsibility for lost documents due to poor packaging.**

Bids will remain valid for 90 days from the date of closing. No faxed, e-mail bids will be accepted, service providers using courier services should ensure that their documents are deposited into the bid box.
