- (4) The tenant or occupier of a property must, on request by a municipality, furnish the municipality with a written statement specifying all payments to be made by the tenant or occupier to the owner of the property for rent or other money payable on the property during a period determined by the municipality

1. INTRODUCTION

The contract is advertised as per Municipal Finance Management Act No.56 of 2003, section 116 (1) (iii) and (2).

2. OBJECTIVES

The objective of these terms of reference is to procure the contract for maintenance and support of the Wireless Local Area Network service on a time and material basis.

3. SPECIAL CONDITIONS

- i) Consideration will only be given to Information Technology service provider specializing in networking and also with wireless network competency and experience.
- ii) The Service Providers should be registered with SITA, on **contract RFB 1183** as Lepelle-Nkumpi is on the government network, which is being administered by SITA.
- iii) Preference will be given to Information Technology service providers who have expertise and experience in networking services.
- iv) The capacity of the company in terms of technical expertise, skills, experience and other resources will play a role.
- v) The service provider must have a valid accreditation certificate for Networking, including Wireless network.

4. SCOPE OF WORK

The scope of service shall cover the following:

- Maintenance of the Wireless Local Area Network in all five municipal offices (Civic Centre, Lebowakgomo Library, Traffic Department, Cultural Centre, Technical Services)
- Maintenance and support of the network hardware of the municipality's ICT infrastructure for both the ICT Production site and the Disaster Recovery
- Replacement of the network equipment's or hardware as and when the need arises.
- Maintaining the network inside and outside the server room, which is the ICT Production, Disaster Recovery Switching Centre.



CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
