

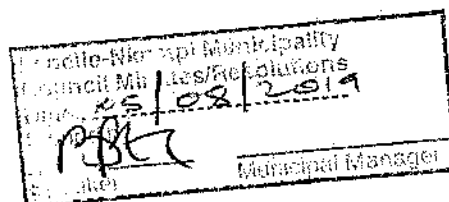

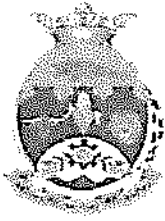

Lepelle-Nkumpi Local Municipality Council.





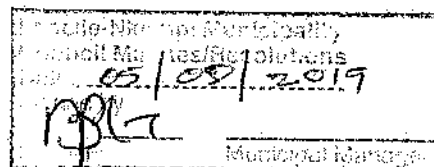

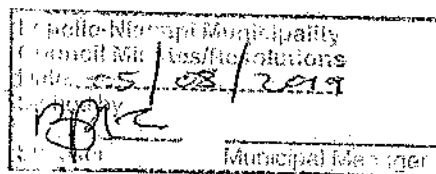

- That Cllr Ramokolo M.M remain ordinary member of the Executive Committee.





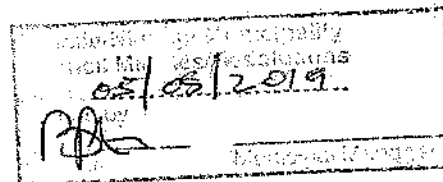

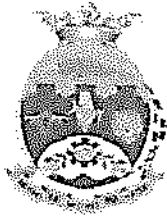
