## Requirements

The Municipality will adjudicate and award bids in accordance with the revised PPPFA Regulations and the Municipality's Supply Chain Management Policy, B-BBEE Level of Contribution on an 80/20 point system, where 80 points will be allocated to price and 20 points to B-BBEE Level of Contribution, OR on a 90/10 points system, where 90 points will be allocated to price and 10 points to B-BBEE Level of Contribution.

Bidders who do not attend the compulsory site briefing (if applicable) will be considered non-responsive and such bids will therefore be disqualified from evaluation. The Municipality reserves the right to negotiate further conditions of the bid and other requirements with the successful bidder, and reserves the right to appoint or not to appoint and is not obliged to accept the lowest bid.

All bid documents will be available upon payment of the relevant non-refundable fee, as from 8 April 2015 from the Supply Chain Management Office, Unit F, Civic Centre, Lebowakgomo during working hours (between 07:30 and 15:00 Monday to Friday, excluding public holidays).

Fully completed, priced and initialled (on all pages) bid documents, with certified copies of relevant documents attached, as well as CIDB Grading (if applicable) and an original Tax Clearance Certificate, must be sealed in an envelope marked with the bid description and number and deposited in the bid box at the Municipal Offices, Civic Centre, Unit F, Lebowakgomo, on or before the closing date at 11:00.

Bids should remain valid for 90 days from the date of closing. No faxed or e-mailed bids will be accepted. Service providers using courier services should ensure that their documents are deposited in the bid box. It is not the responsibility of municipal officials to accept bids from courier services and place these in the bid box.
