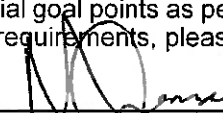

No late quotations will be accepted.

In terms of MFMA Circular No 81, issued by National Treasury, it is compulsory as from 1 July 2016 for all prospective service providers to Local Municipalities to be registered on the web based **CENTRAL SUPPLIER DATABASE (CSD)**. It must therefore be understood that only bids from suppliers registered on the **Central Supplier Database** will be considered. The Lepelle-Nkumpi Local Municipality does not bind itself to accept the lowest or any bid and the Municipality reserves the right to accept the whole or part of any bid and further reserves the right to re-advertise if it so wishes to. Quotations will be evaluated on an 80/20 preference point system. Whereas 80 points will be for price and 20 for special goal points as per the Preferential Procurement Regulations 2022.
